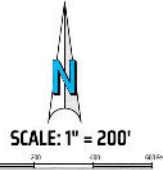

DISTANCES SHOWN HEREON ARE SURFACE DISTANCES UNLESS OTHERWISE NOTED. TO OBTAIN GRID DISTANCES (HORIZONTAL) DIVIDE BY A COMBINED SCALE FACTOR OF 1.0002352490399 (CALCULATED USING GEODESIK).

(CM) INDICATES CONTROLLING MONUMENT FOUND AND USED TO ESTABLISH PROPERTY BOUNDARIES.

ALL EXTERIOR PROPERTY LINE BEARINGS AND DISTANCES ARE DEED CALLED AND MEASURED, PER THE DEED RECORDED IN DOCUMENT NO. 2107245, DRWCT.

- 6. 10' BOUNDARY LINE AGREEMENT IN VOLUME 463, PAGE 505, DRWCT, DOES APPLY TO THE COMMON LINE OF THIS TRACT AND THE ADJOINING CHERRY TRACT AS SHOWN HEREON.
- 7. ALL OTHER ITEMS ARE NOT SURVEY ITEMS AND/OR ARE NOT ADDRESSED BY THIS PLAT.
